Attention is invited to this Office Notification dated 20.11.2024 & 13.03.2025 vide which the list of candidates shortlisted for interview for the posts of 'Scientists' and 'Senior Scientists' against CSIR-CIMAP Advt No 1/2022 was notified and the representations received thereon were disposed, respectively.

2 **Date and Venue of Interview:** All the shortlisted candidates are hereby informed that the interview for the aforementioned posts has been scheduled from **26<sup>th</sup> May to 30<sup>th</sup> May, 2025 through physical mode** as per the details given in the attached Annexure. The interview will be held at **CSIR-CIMAP, Kukrail, Picnic Spot Road, Lucknow-226015.**

3 **As per the decision of CSIR-RAB, New Delhi, the Interview for the Scientist (Agronomy); Post Code S0122 (Reserved for EWS) has been cancelled** due to lack of sufficient number of candidates.

4 **The scheduled interview is likely to continue till late evening.** Therefore, the candidates in their interest are advised to make their own arrangements for stay, travel etc.

5 **Time for Reporting for interview:** All the candidates called for interview have to report as per the time schedule mentioned in the attached **Annexure.**

6 **The Call Letters** to the candidates shortlisted for interview is being sent to their respective address through **speed post as well as through email** indicated in their application form. Candidates without call letter will not be allowed to appear for interview.

7. **Candidature for Interview is provisional:** If it is found at any point of time, even after selection, that the candidate does not fulfil any of the conditions of eligibility for the post advertised vide CSIR-CIMAP Advt No 1/2022 and the Screening Criteria, his / her candidature will be summarily cancelled without any notice and no appeal against such cancellation will be entertained. Candidates are, therefore, advised to check carefully and satisfy themselves that they fulfil all conditions of eligibility for the post they have applied for. Mere appearing for interview does not confer any right on them, either implicit or explicit for selection/permanent appointment in CSIR-CIMAP.

## 8. Verification of Documents:

- a) All candidates called for interview shall bring their Original Certificates of all educational qualifications obtained by them, 02 recent passport size photographs, all Mark Sheets thereof, the certificates of experience(s), Patent(s), Date of Birth, the Caste/ Community / EWS, (in the prescribed format, if applicable) copies of Publication(s) substantiating their claim made in their Application Form, for verification by CSIR-CIMAP. In addition, the candidates should also bring **self-attested photocopies** of all the aforementioned certificates/documents. **It must be noted that the latest caste/community/EWS certificate must be produced at the time of interview.**
- b) Document/ Certificate furnished in a language other than Hindi or English, must be accompanied with an English transcript of the same duly attested by a Gazetted Officer or Notary.
- c) Candidates who fail to produce satisfactory proof of qualification / experience and other requisite documents shall not be allowed to attend the interview.

## 9. General Instructions

- a) All the candidates are required to bring with them a Photo Identity Card, like Aadhar Card, Voter I-Card or any other Photo ID card issued by any Government Agency for verification.
- b) Candidates employed in Government / Semi-Government organizations /Institution /Departments / Autonomous Bodies etc. shall have to bring **No Objection Certificate (NOC) from their present employer** to the effect that in the event of their being selected for appointment, they will be relieved without delay. **The candidates who fail to produce NOC will not be allowed to appear in Interview.**
- c) Every candidate will be required to sign attendance sheet before the commencement of their Interview.
- d) The candidates are permitted to converse either in ENGLISH or in HINDI during interview.
- e) **Any request for change in Date / Time / Venue of the interview will not be entertained under any circumstances.**
- f) The outstation candidates will be entitled to get second class Railway fare (mail/express) both ways from his/her normal place of residence or from the place of undertaking the journey (within India), whichever is nearer to Lucknow, by shortest route, on production of Journey Proof as per extant rules.
- g) The candidates should make their own arrangement for stay at Lucknow. CSIR-CIMAP shall not take any responsibility for making such arrangements. **No request(s) related to Guest-**

- h) Candidates found using or attempting to use any unfair means or canvassing in any form and / or bringing any political influence will be treated as a disqualification for the post applied for and shall forfeit his/her Candidature.
- i) The Director, CSIR-CIMAP reserves the right to cancel the Notification without assigning any reason thereof or reserves the right not to fill up the posts.

The decision of the Director, CSIR-CIMAP in all matters relating to eligibility, acceptance or rejection of applications will be final and binding on candidates.
